- **Individual Memberships**

- 1) The annual dues for an Individual Membership are \$200.
- 2) Minimum age of 18.
- 3) All potential members will be vetted by the Membership Committee prior to presentation to the board.
- 4) As an individual member you will purchase a \$450 annual meal plan. You may pay this at one time, split it up biannually, or even quarterly.

- **Corporate Memberships**

- 1) 2-3 members from a company may share one Corporate Membership. The annual dues for each member are \$150.
- 2) Minimum age of 18.
- 3) All potential members will be vetted by the Membership Committee prior to presentation to the board.
- 4) There will be only one \$450 annual meal plan charged per membership. -If more than one member attends a weekly meeting, \$10 will be charged per additional member who chooses to eat lunch.

- **Family Memberships**

- 1) 2-3 members of a family may share one Family Membership. The annual dues for each member are \$150.
- 2) Minimum age of 18.
- 3) All potential members will be vetted by the Membership Committee prior to presentation to the board.
- 4) There will be only one \$450 annual meal plan charged per membership. If more than one member attends a weekly meeting, \$10 will be charged per additional member who chooses to eat lunch.
